Dear All,

We are constructing the transmission line 132 kV Sørmarkfjellet Hofstad". Our Client and owner of the line is TrønderEnergi.

This transmission line will, when finished, transport the generated electric power from Vindpark Sørmarkfjellet into the national grid through the substation in Hofstad.

The majority of the line is passing through Osen commune, while the remaining sections are located in Åfjord and Flatanger kommune.

We are constructing this line for exactly 1 year (the commencement was on April 1<sup>st</sup> 2019).

Due to recent outbreak of corona virus pandemic, we are forced to change our regular working shifts and time scheduling. Due to this reason, instead of normal working shifts and leaving to Croatia during the Easter holidays, we decided to stay working on the construction of the line.

Among this, we are planning to work on following national holidays as well;

9th of April – Maundy Thursday – National holiday

10th of April – Good Friday – National holiday

13th of April - Easter Monday - National holiday


In this regard, through this Letter we want to formally inform you about our intentions to work. The same issue has been already communicated to our Client.

<u>Construction of foundations;</u> - INSIDE ZONE (RECTANGLES) 2, 3, 5 // OSEN <u>Erection of poles;</u> - INSIDE ZONE (RECTANGLES) 2, 3 // OSEN <u>Sagging, Clamping;</u> - INSIDE ZONE (RECTANGLES) 9, 8, 7 // ÅFJORD <u>Stringing (maybe);</u> INSIDE ZONE (RECTANGLES) 1, 2, 3 // FLATANGER

For all of this activities, the helicopter service will be used.

Since the works and helicopter activities will be performed in the mountain areas, the nearby settlements will not be affected by noise or by any other way caused by our working activities.
